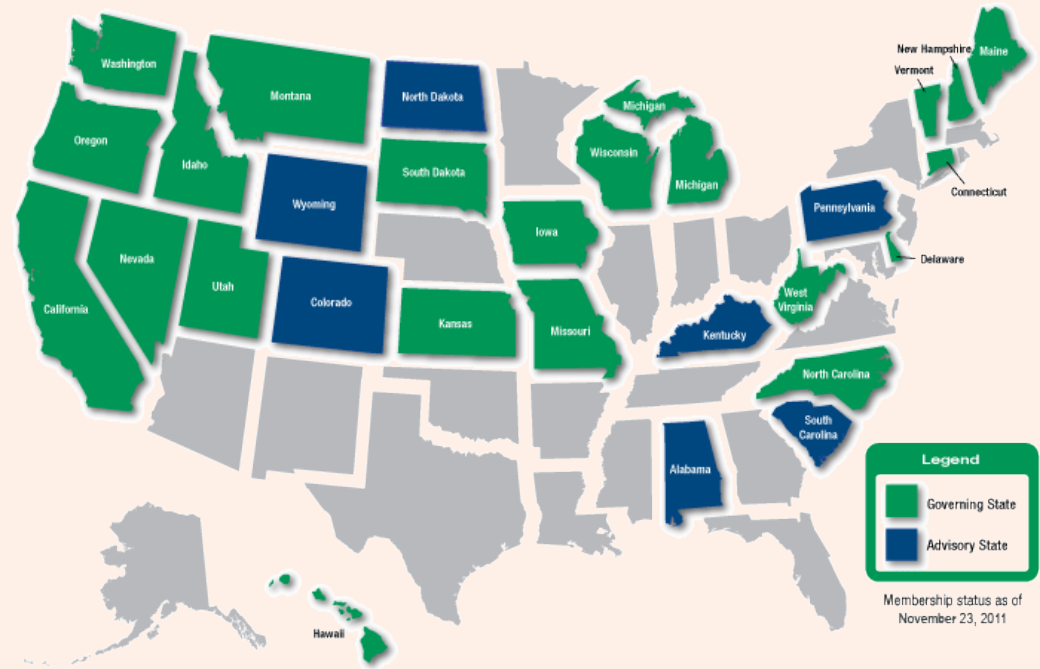

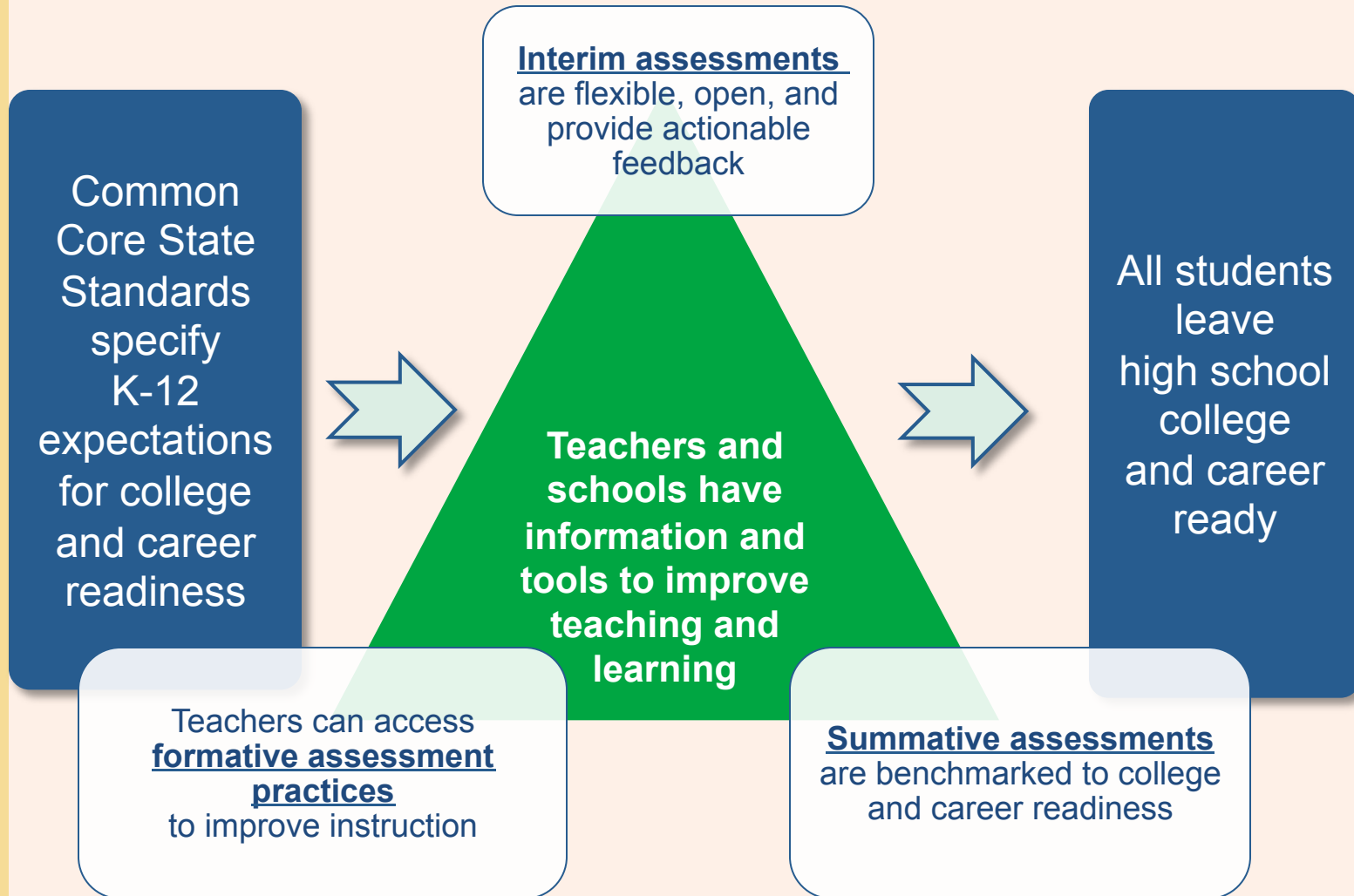
The SBAC Goals

- The assessments shall be **operational** across Consortium states in the **2014-15 school year**

SBAC System

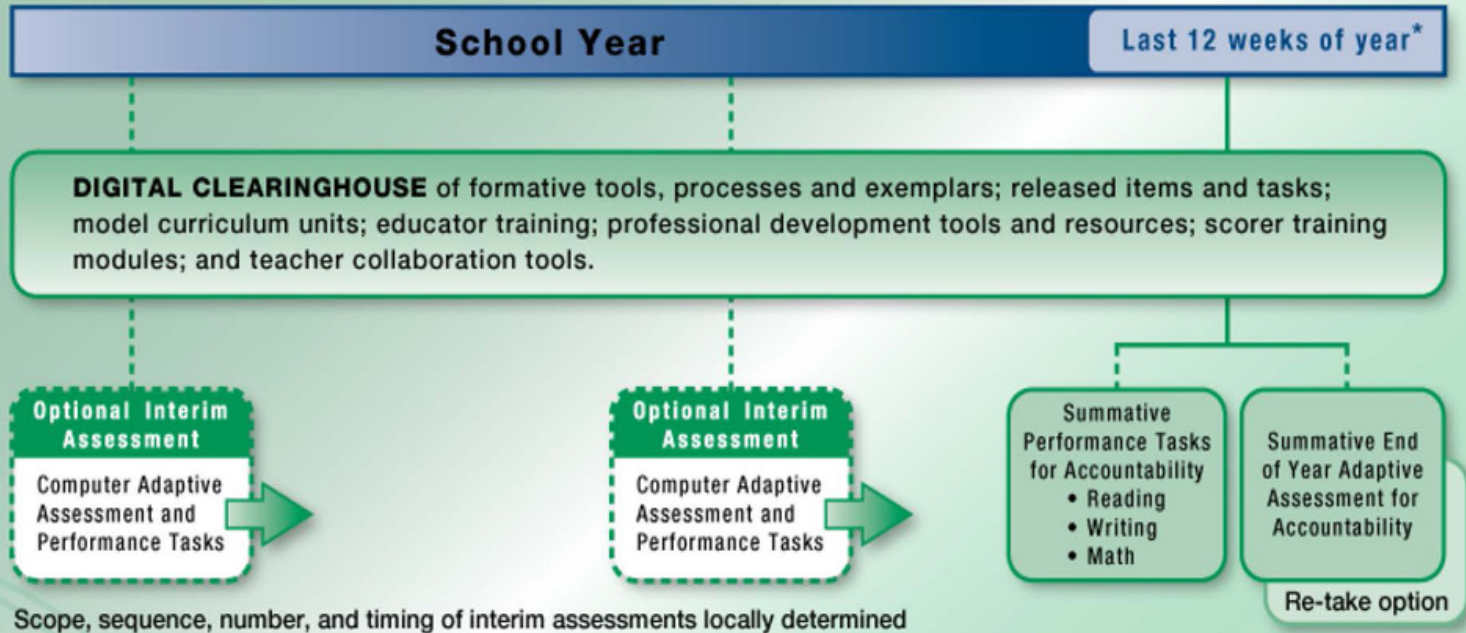

English Language Arts and Mathematics, Grades 3–8 and High School

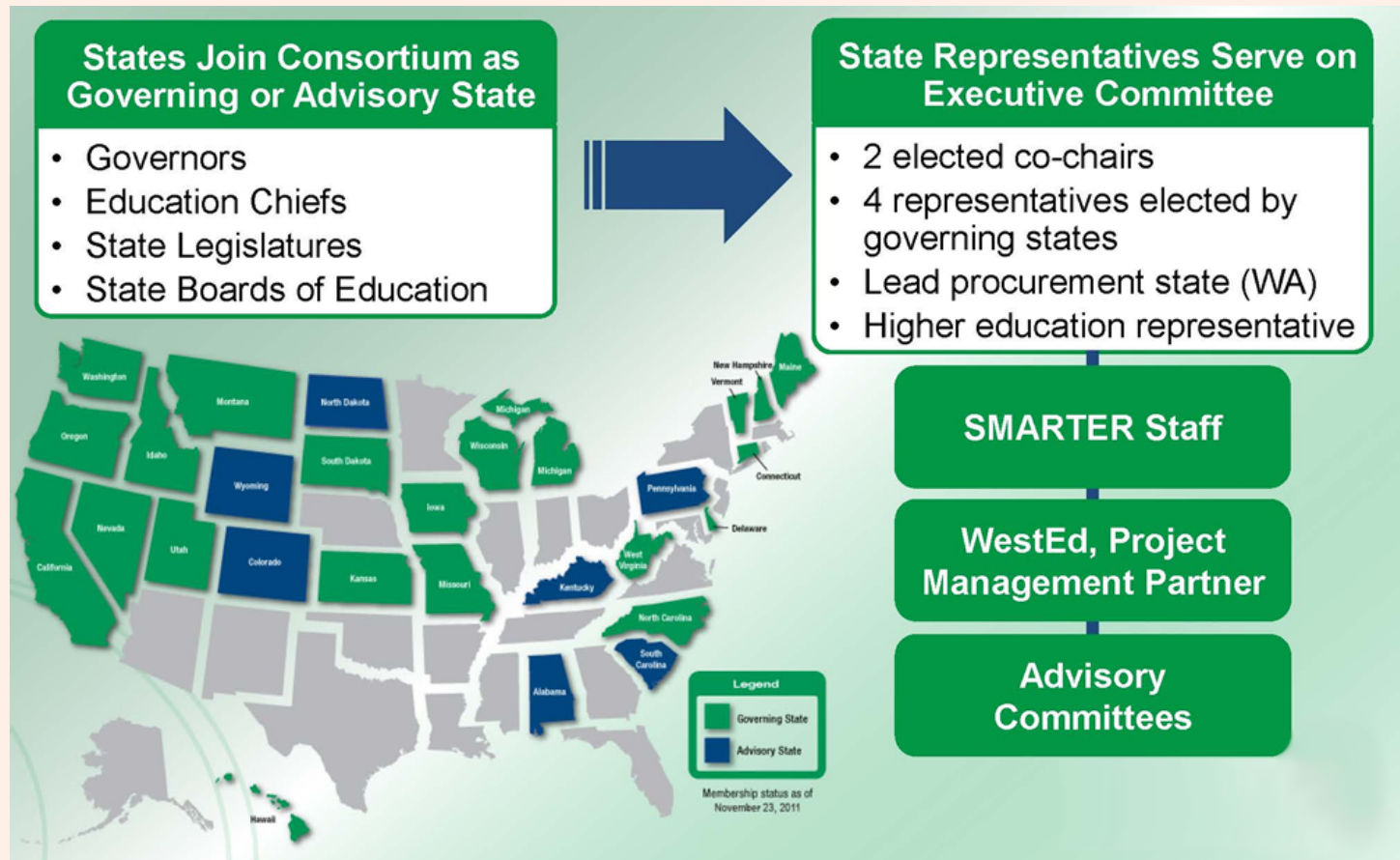


* Time windows may be adjusted based on results from the research agenda and final implementation decisions.

Work group engagement of 90 state-level staff:

Each work group:

- Led by co-chairs from governing states
- 6 or more members from advisory or governing states
- 1 liaison from the Executive Committee
- 1 WestEd partner
- Higher Ed representative

Work group responsibilities:

- Define scope and time line for work in its area
- Develop a work plan and resource requirements
- Determine and monitor the allocated budget
- Oversee Consortium work in its area, including identification and direction of vendors

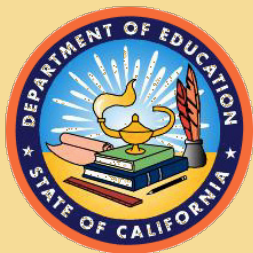

IT Readiness Tool Update

- Assesses current capacity and compares to the technology that is expected to be required for new SBAC assessments
- Areas: devices, devices to tester ratio, network infrastructure, and staff and personnel
- Performs gap analysis and recommended areas where LEAs will need to upgrade technology

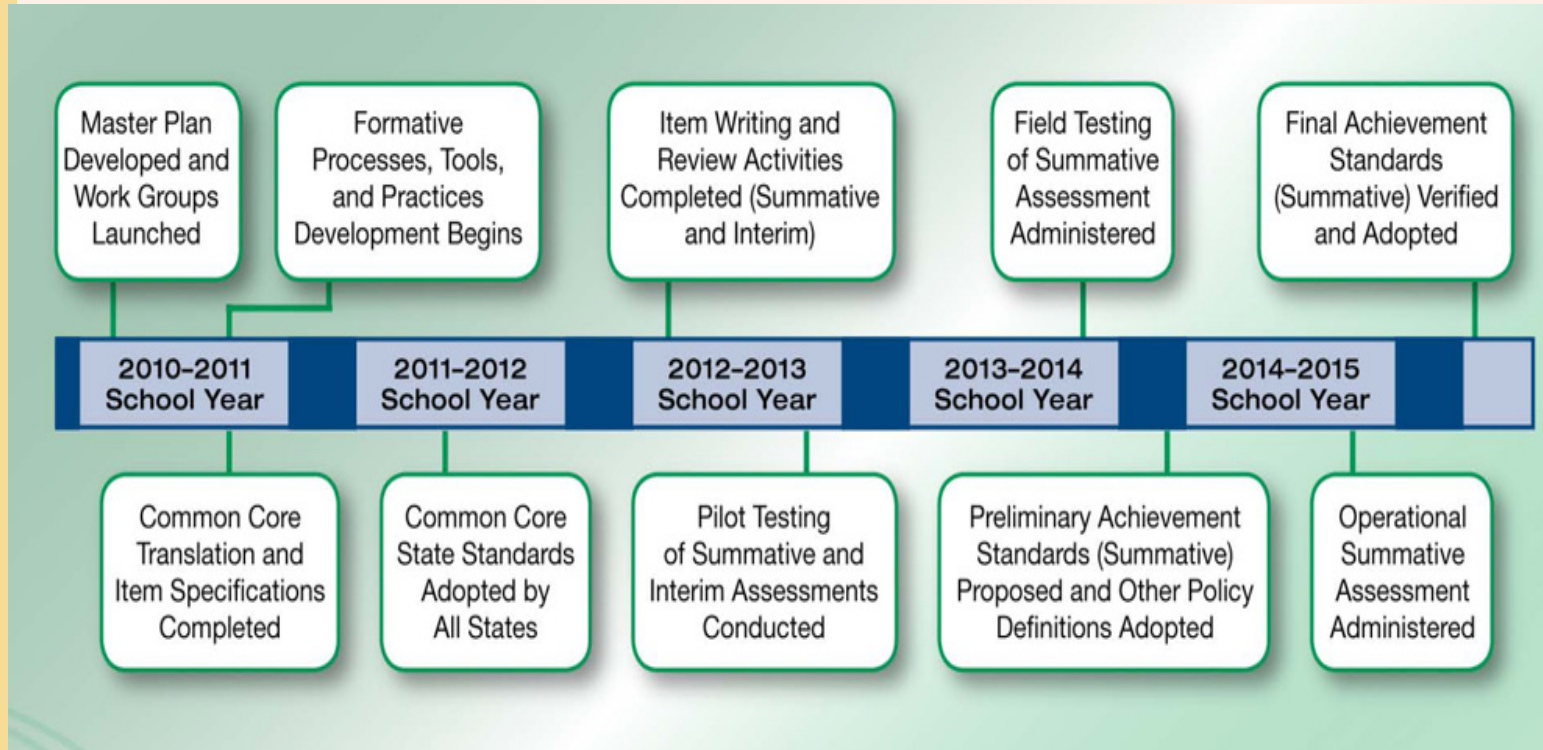
IT Readiness Tool (cont.)

- First data collection window will be in Spring 2012
- Subsequent data collections will occur each spring and fall through 2014
- Automated data collection plus manual survey
- Challenge is determining the computers that are available for testing
